From the President

ACCE members and colleagues:

Was that a huge sigh of relief I heard the morning after the November 6th election results were in? Bear in mind that I was enjoying the paradise of Costa Rica's west coast during the election, having cast my absentee ballot a couple of weeks prior to election day. I suspect many of you, like colleagues of mine, had gone to bed on election night, thinking that the California Community Colleges would, in fact, be heading toward an unfathomable abyss which would forever change public education in California. What a wonderful surprise to wake the next morning to the momentous news that Californians wholeheartedly endorsed the work that we do with their votes that helped Proposition 30 pass. But obviously, we are not yet out of the woods and many challenges await us.

Speaking of challenges, have you read the Legislative Analyst's Office Report, "Restructuring California's Adult Education System," released last December? (If you haven't yet, you can access the report at http://lao.ca.gov/reports/2012/edu/adulteducation/restructuring-adult-education-120412.pdf) The LAO presents a fairly scathing description of condition of California's Adult Education system. But I was heartened by the fact that it did not focus so much on the job we are doing as educators, but instead, the criticism was directed toward the fractured nature of the funding we receive and the disconnect between K-12 adult education programs and our noncredit programs. On the positive side, the report calls for adequate funding, but at the same time, recommends a

performance based, regional model. Several other recommendations made by the LAO are of deep concern, including the recommendation to eliminate all but six of the currently funded noncredit categories. This would mean that state supported Older Adult and Parenting programs would be things of the past. With diminishing social resources and a burgeoning older population and children entering school without a solid foundation geared toward learning, this recommendation is one that ACCE will strongly oppose. ACCE board members are at the table where these issues are being discussed and we will need to hear from you, our members, to ensure that we are capturing your concerns regarding these topics.

This is hard work but it is work that the members of ACCE are used to taking on. I'd like to recognize Valentina Purtell, who, in addition to representing our concerns at the quarterly California Department of Education (CDE) adult education meetings also took on the spur of the moment task of addressing the Board of Governors when the LAO's report was presented to them earlier this month. Valentina did both: she addressed our concerns about the report but moreover, made clear the need to have ACCE at the table when issues affecting noncredit programs are discussed.

In a like vein, Donna Burns from Mt. SAC, ACCE's 2nd Vice President, Membership, attends the Chief Information Officers meetings to ensure that we are kept abreast of developing issues that affect our programs.

And as an aside, here's a surprising fact: at the fall CIO conference, there were 61 new CIOs! That means that 61 colleges have CIOs who may not know about your Community or Continuing Education programs! I urge those of you with new CIOs to make contact with them and

ensure that they understand how critical your programs are to your college's success and presence in the community.

Looking to the New Year: 2013 promises to bring even more changes. We have a new Chancellor, Dr. Brice Harris, who has graciously agreed to address our Northern Conference on February 27th. Our Southern Conference is scheduled for March 14th at the historic Mission Inn in Riverside. Both conferences will be jampacked with informative breakout sessions so save those dates and plan to attend. We'll also be asking for nominations for the Annual ACCE Awards. These awards are based on selfnomination so start thinking about your exemplary programs and the staff who run them. It's a great recognition for our programs. More information will be posted soon on the ACCE website (acceonline.org).

So what are other ways you can stay involved and up to date? How about our ACCE listservs? At one time, the listservs were a great resource for posting questions and getting quick answers, especially for folks new to the system. This resource is largely going unused, perhaps made obsolete by social media. Well! Did you know that ACCE has a Facebook page? Check us out (search for Association of Community and Continuing Education rather than ACCE). We're hoping to have a page chalk full of information about your programs. Feel free to post information or pictures about your programs or contact Betty Sedor, our Community Education Council Leader, if you have questions on how you might use it.

In closing, remember that ACCE is a tremendous resource for each you. Our organization's strength is built on the talents and energy of people who are passionate about the jobs they do and willing to roll up their sleeves to get

accomplish the important work we need to get done. Thank you all for your commitment to your respective communities, your colleges, and especially to your students.

ACCE Responds to the LAO Recommendations on Restructuring Adult Education.

On Monday, January 7th, at the Board of Governors (BOG) meeting, ACCE presented a preliminary response to the LAO's report on restructuring adult education. The report was introduced to the BOG members by Paul Steenhausen, an LAO analyst. Here are the highlights of Paul's presentation:

- Adult education is one of the most confusing and challenging systems in the state but having two primary providers, K-12 and community colleges, presents its own merits and challenges.
- K-12 is the primary provider of adult education with respect to the number of sites; however community colleges serve more students statewide. Note that LAO defines all pre-collegiate courses, credit and noncredit, as adult education.
- K-12 focuses on literacy, Adult High School Diploma, GED, and low-level ESL, whereas community colleges offer more courses in CTE and high-level ESL.
- originally the LAO planned on recommending that community colleges assume the role of providing adult education in California but later found the recommendation not practical for at least two reasons: not all regions, especially rural, have community colleges in the vicinity of the pockets of student population in need of adult education and it did not seem reasonable to remove a service provided by K-12 for more than a century. California is in a unique position to be able to leverage strengths of each provider;

thus, the recommendation is to leave the shared responsibility to both K-12 and community colleges with the condition that additional funding specifically earmarked for adult education will be allocated.

 A statewide workgroup determining the delineation of the noncredit and credit roles in offering pre-collegiate and short-term vocational courses needs to be formed.

The ACCE's response included a strong support of retaining a comprehensive mission of community colleges and opposition to the proposed limitation of the eligible apportionment instructional areas to elementary and secondary education, ESL, citizenship, workforce preparation, vocational education, apprenticeship, and offerings for adults with disabilities. Once again, the ACCE affirmed its role of representing and advocating for the field of noncredit education and requested to be an essential partner in developing policies related to the noncredit students.

We are working on a comprehensive position related to the LAO recommendations and the governor's proposal and will call for the feedback of the ACCE members in the near future.

Another sign of success is vendor participation – this year, spots were completely booked; and with upwards of 30 vendors, there was material and information for every need.

College to Career for Students with Intellectual Disabilities

The North Orange County Community College District/School of Continuing Education (NOCCCD/SCE) Disabled Student Programs and Services (DSPS) Program was one of five California Community College programs to receive funding through the Department of Rehabilitation to create a College to Career (C2C) program. Other C2C programs are currently offered at San Diego Community College District, Sacramento City College, College of Alameda and Santa Rosa Junior College. C2C enables the DSPS agency to provide enhanced support to students with intellectual disabilities who want to take classes with their nondisabled peers. Students participate in classes fulfilling the same requirements that are expected of all other students. The supplemental educational support they receive may include the use of adaptive technology, such as an Echo Pen, small group or one to one tutoring from an Educational Coach, testing in a distractionreduced environment, and notes or PowerPoint slides in advance.

In 2010-2011, NOCCCD SCE/DSPS selected its first cohort of 20 students, which we call Cohort '11, through a rigorous application and interview process. Upon acceptance into the program, each student met with a C2C Specialist to develop his or her educational and vocational plan. Within the first year, students enrolled in noncredit offerings through SCE, such as Early Childhood Education, Personal Care Attendant, and various computer offerings or they enrolled in credit offerings through Cypress College or Fullerton College taking various classes.

In 2011-2012, students of the Cohort '11 continued working or were finishing up their coursework and exploring paid and unpaid vocational experiences to prepare them for ultimate goal of competitive employment. An additional 21 students, Cohort '12, have joined the program to begin developing their educational and vocational plans and enroll in inclusive courses to reach their goals.

The C2Cs continue receiving close support from the Department of Rehabilitation, UCLA Tarjan Center and the California Community College Chancellor's Office. Data is collected and will be combined with other research that is being conducted throughout the nation at the University of Massachusetts Think College program.

Information Fair at Santa Ana College, School of Continuing Education

A lively spirit flourished at Santa Ana College School of Continuing Education (SCASCE) on Tuesday, October 9th at the innovative Information Fair.

Organized by the faculty, staff and ASB with the support of the administration, this year's Information Fair offered an interactive and innovative experience where faculty not only showcased programs and services, but offered students the chance to employ their language and life skills. Students had a great opportunity to ask important questions on academic, vocational, and transition programs; as well as specialized services available to them. Faculty and volunteers energetically shared their knowledge with students which boosted students self confidence and enticed them to further their education.

The fair was a great success where students felt at ease to request information. In other words, they felt as if they were walking into a space of undiscovered knowledge. More than 1000 students participated in this event, with a success rate of 70% percent of the student evaluations collected. Most students rated the event as "excellent", as one of the students described it "i love this event...a lot of new information".
