Section 3: Vacancies shall be filled by presidential appointment.

#### ARTICLE VI - CONFERENCE AND MEETINGS

- Section 1: There shall be a minimum of one annual business meeting.
- Section 2: Special meetings may be called by the officers or by a petition of the majority of the membership.
- Section 3: Any member of the Executive Board may initiate an item for the agenda of any meeting.

### ARTICLE VII - AMENDMENTS

- Section 1: Amendments to the Constitution shall be proposed by an officer or by a petition signed by 25 percent of the members.

### ARTICLE VIII - DEDICATION AND DISSOLUTION

Section 1: The property of the organization is irrevocably dedicated to social welfare purposes, and no part of the net income or assets of this organization shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private persons. Upon the dissolution of the organization, its assets remaining after payment, or provision for payment, of all debts and liabilities of this organization shall be distributed to a non-profit fund, foundation or corporation which is organized and operated exclusively for social welfare purposes and which has established its tax exempt status under an approved section of the Internal Revenue Code, Section 501, (c) 3 or (c) 6.
